For graphics installed in desert, tropical, intense sun or high environmental pollution regions, durability ratings will be prorated by 60%.

# **CLAIM REMEDY**

In the event of a warranted failure, as specified above, Arlon reserves the right of inspection. Arlon will, at our option, replace defective materials or refund purchase price thereof. All documentation and administration will be handled through the formal customer service complaint system at Arlon. To receive remedy, Arlon or the local distributor must be notified of a claim within 30 days of vinyl failure. Date of installation, material lot number, installation procedures, substrate and environmental conditions must be supplied with the description of failure.
